# **Committee Updates**

### New NACAP Committee to Track Federal Legislation

The NACAP Board of Directors recently created a Public Policy committee to evaluate legislation or other policy changes that could affect member programs, as well as provide information and education about ACPs. The Public Policy committee will serve as a central point of contact for entities or agencies requesting information from NACAP that could affect new laws or policies. Anyone interested in serving on this committee may contact Committee Chair Betty McEntire at <u>bmcentire@azsos.gov</u>.

As announced in the Autumn 2017 newsletter, through the efforts and initiative of the Missouri Secretary of State's Office, federal legislation was introduced in September 2017. The legislation would require federal agencies to accept the substitute address of ACP participants. Bills <u>S. 1889</u> and <u>H.R. 3887</u> have both been referred to congressional committees. The Public Policy committee has already had the opportunity to provide information about ACPs to congressional committee personnel and will continue to track any further action.

## **Executive Committee**

This committee consists of the President, Vice President, Treasurer, and Secretary. The committee meets monthly and communicates frequently through email to discuss questions that need immediate attention. Most recent work has been focused on developing an interest sheet for states to complete and submit if they are interested in hosting a future NACAP conference.

### **Stakeholder Solutions Committee**

A top priority for this committee is working with the Department of State to create a document regarding a passport process for participants. A draft of the proposed guidance will be submitted to the Department by the end of January in the hopes that a process will be in place sometime in March. Potential rulemaking opportunities may also be discussed at a later date.

This committee is also excited to be meeting with representatives from the United States Postal Service in January. They hope to begin a collaborative relationship that will benefit participants nationwide.

### **Bylaws & Membership Committee**

This committee meets via teleconference every other Friday at 10:30am Central Time. Currently, committee work is focused on expanding the bylaws to include other levels of NACAP membership so that non-ACP organizations can be NACAP members (for example, state DV coalitions), not with the same full benefits of an ACP but with some benefits - such as a possible conference rate discount. Exactly how this should all happen will be determined by the committee over the next several months and then suggestions will go to the full Board for approval. This committee currently has four members and could use one or two more people. Please contact committee chair, Dianna Umidon if you are interested in joining this committee. # **Member Updates**

## Washington ACP Partners with Stakeholders to Better Protect Families

With the help of key stakeholders, the country's first Address Confidentiality Program is laying the groundwork to strengthen services and keep families safe. Washington's innovative substitute address and mail-forwarding service began in 1991 and currently helps protect more than 4,500 survivors and children who are targets of stalking, domestic violence, sexual assault and trafficking. In 2011, the ACP expanded to include criminal justice employees who have been threatened or harassed because of their work.

Washington's ACP recently held a statewide summit sponsored by Secretary of State Kim Wyman. More than 45 local, community and state leaders explored many aspects of family life impacted by the ACP-- like buying a home, raising children and educating youth about social media. After 25 years with the program, one participant emphasized the continued value of ACP and the need to develop services that allow children enrolled in ACP to lead full lives.

Program managers are currently evaluating recommendations and innovative ways to educate families while keeping their addresses secure and out of the hands of perpetrators.

Washington's ACP recently celebrated more than 25 years of public service. In 2002, the program won the Susan Laurence Memorial Award for Professional Innovation in Victim Services and was honored by the U.S. Department of Justice.

### Maine ACP Office Donates to Shelter

The Maine Address Confidentiality Program and coworkers from the Office of the Secretary of State donated supplies for the *Adopt-a-Shelter Christmas Program* supporting a local DV agency this holiday season. Program manager, Nicole Ladner, shares, "Some days can be difficult in this field and you wish you could do more. It is good for the soul to give to the shelters and the people they support. My colleagues and I are pleased to help out."
